Discussion on Proposed Motion

The proposed motion is to authorize the purchase of a Dump Truck from Doggett Freightliner in the amount of \$191,561.10.

Background

The new Dump Truck will replace a Dump Truck that is 24 years old and is no longer road worthy. This truck will be used to haul dry sludge directly from our sewer treatment plant to the saline county landfill and will prevent us from having to dump the sludge in our drying beds where the sludge becomes saturated when it rains causing us to transport and pay for dumping heavier material. Solicitations were sent to 3 vendors, with 2 bids received. The bid summary and recommendation are listed below with the recommendation in bold:

Staff recommends the purchase from Doggett Freightliner in the amount of \$191,561.10. This is the lowest bid received and the equipment meets or exceeds all requested specifications. This bid is \$11,561.00 over budget due to inflation of material and production costs. The approved budgeted amount for this equipment purchase is \$180,000.00.
